#### Note- 1 General Information & Activity of Trust

Salaam Baalak Trust is an Indian non-profit, non-governmental organisation that provides a sensitive and caring environment for street and working children. The primary objectives of the Trust are the relief of the poor, promotion of education, and social welfare in Delhi and the NCR region of India.

Thirty-seven years ago, the founding Trustees discovered the world of street children within the harsh, raw, underbelly of Delhi. And yet, it was a life these children had chosen in preference to home and family - which had obviously become entirely intolerable. There is so much missing from the lives of these children - food, security, health, education and love. All these, the Trustees were convinced; they needed and had a right to - a secure space to sleep, to play, and to dream. This realisation paved the way for creation of Salaam Baalak Trust (SBT).

To provide a safe and enabling environment to children rescued from streets, Salaam Baalak Trust runs 19 Centre's in different parts of the capital. The Trust runs 12 contact point and community contact points, 7 shelters homes providing full time and short stay facility to children in need of care and protection.
